SECOND AMENDMENT
TO
COOPERATIVE PURCHASING MASTER AGREEMENT NO. 00218
POLICE RADAR/LIDAR SPEED ENFORCEMENT & SPEED ADVISORY SYSTEMS, PARTS, AND ACCESSORIES

This Second Amendment (“Amendment”) to Cooperative Purchasing Master Agreement No. 00218 is made and entered into by and between the State of Washington acting by and through the Department of Enterprise Services, a Washington State governmental agency (“State”) and Kustom Signals, Inc., a Kansas Corporation (“Contractor”) and is dated as of December 15, 2020.

RECITALS

- A. State and Contractor (collectively the “Parties”) entered into that certain Cooperative Purchasing Master Agreement No. 00218 for Police Radar/Lidar Speed Enforcement & Speed Advisory Systems, Parts, and Accessories dated effective as of February 20, 2019 (“Contract”).
- B. The Parties previously amended the Contract one (1) time.
 - a. Amendment 1 (product addition) effective on September 30, 2019.
- C. The amendment set forth herein is within the scope of the Contract.
- D. The Parties now desire to amend the Contract as set forth herein.

AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, the Parties hereby agree to amend the Contract, as previously amended, as follows:

- 1. **TERM.** The term of the contract is amended to extend the term thirty-six (36) months to February 19, 2024.
- 2. **COVERED PRODUCTS.** Pursuant to Section 3.2 Ability to Modify Scope of Master Agreement, the Contract is hereby amended to remove and revise the descriptions of products listed below.

This Amendment constitutes the entire agreement and understanding of the Parties with respect to the subject matter and supersedes all prior negotiations and representations. In the event of any conflict between this Amendment and the Contract or any earlier amendment, this Amendment shall control and govern. This Amendment may not be modified except in writing signed by the Parties.
5. AUTHORITY. Each party to this Amendment, and each individual signing on behalf of each party, hereby represents and warrants to the other that it has full power and authority to enter into this Amendment and that its execution, delivery, and performance of this Amendment has been fully authorized and approved, and that no further approvals or consents are required to bind such party.
6. ELECTRONIC SIGNATURES. A signed copy of this Amendment or any other ancillary agreement transmitted by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original executed copy of this Amendment or such other ancillary agreement for all purposes.
7. COUNTERPARTS. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which counterparts together shall constitute the same instrument which may be sufficiently evidenced by one counterpart. Execution of this Amendment at different times and places by the parties shall not affect the validity thereof so long as all the parties hereto execute a counterpart of this Amendment.
